


# Daily Report 10/2022

17 January 2022<sup>1</sup>

#### **Summary**

- In Donetsk region, between the evenings of 14 and 16 January, the SMM recorded 129 ceasefire violations, including 20 explosions. In the previous reporting period, it recorded 49 ceasefire violations in the region.
- In Luhansk region, between the evenings of 14 and 16 January, the Mission recorded 214 ceasefire violations, including 118 explosions. In the previous reporting period, it recorded 105 ceasefire violations in the region.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded one ceasefire violation inside the disengagement area near Petrivske.
- The SMM monitored the operation and repair of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at five entry-exit checkpoints and four corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The SMM visited two border crossing points and monitored areas near the border outside government control in Donetsk region.
- The Mission's freedom of movement continued to be restricted, including at three checkpoints of the armed formations in Donetsk region. Its UAVs encountered multiple instances of GPS signal interference assessed as caused by probable jamming\*



In Donetsk region, between the evenings of 14 and 16 January, the SMM recorded 129 ceasefire violations, including 20 explosions (four airbursts and 16 undetermined). The majority of ceasefire violations occurred in areas north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk) and east of Maiorsk (government-controlled, 45km north-east of Donetsk). In the <u>previous reporting period</u>, the Mission recorded 49 ceasefire violations in the region, some of which also occurred near Shyrokyne.

In Luhansk region, between the evenings of 14 and 16 January, the SMM recorded 214 ceasefire violations, including 118 undetermined explosions. All ceasefire violations occurred in areas south-west and north-east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk). In the <u>previous reporting period</u>, the Mission recorded 105 ceasefire violations in the region.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 101,599 ceasefire violations in both Donetsk and Luhansk regions (including 27,902 explosions, 24,453 projectiles in flight, 440 muzzle flashes, 469 illumination flares and at least 48,335 bursts and shots).

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

On 15 and 16 January, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

During the reporting period, the SMM camera in Zolote recorded one undetermined explosion and 18 projectiles in flight assessed as outside the **disengagement area near Zolote** but within 5km of its periphery. During the same period, SMM patrols heard 117 undetermined explosions, and 78 bursts and shots of heavy-machine-gun fire and small-arms fire, all also assessed as outside the area but within 5km of its periphery.

On 15 and 16 January, near the checkpoint of the armed formations south of the disengagement area, the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them). On both days, the SMM again saw the seven previously observed containers located south of the area's southern edge and inside the disengagement area. It also observed that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

During the evening, on 14 January, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded one projectile in flight assessed as inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk).

On 15 and 16 January, while positioned at three locations near the disengagement area, the Mission observed a calm situation.

#### Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

#### Indications of military and military-type presence in the security zone

The SMM saw one armoured personnel carrier in a government-controlled area of Donetsk region and six armoured combat vehicles in non-government-controlled areas of Donetsk region, the latter in a zone within which deployment of heavy armament and military equipment is proscribed according to Point 5 of the Memorandum of 19 September 2014. ## The SMM followed up on reports of a leak of ammonia gas in non-government-controlled Horlivka, Donetsk region

On 16 and 17 January, the SMM followed up on reports of an alleged leak of ammonia gas from a factory in Horlivka (non-government-controlled, 39km north-east of Donetsk). The Mission observed a calm situation and will continue to follow up.

#### SMM facilitation of the operation and repair of critical civilian infrastructure

On 15 and 16 January, the Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk).

On both days, the SMM monitored repair to water pipelines near Toretsk (formerly Dzerzhynsk, government-controlled, 43km north of Donetsk).

On 16 January, the Mission also monitored repair to water pipelines near Horlivka (non-government-controlled, 39km north-east of Donetsk).

#### Situation at entry-exit checkpoints and corresponding checkpoints

On 15 and 16 January, in Donetsk region, the Mission observed that the entry-exit checkpoint (EECP) near Marinka (government-controlled, 23km south-west of Donetsk) was open, but that the corresponding checkpoint of the armed formations near Kreminets (non-government-controlled, 16km south-west of Donetsk) was closed.

On 16 January, the SMM noted that the EECP near Maiorsk was open, but that the corresponding checkpoint of the armed formations near Horlivka was closed.

On 15 January, in Luhansk region, the Mission observed that the EECP near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the repaired span of the Stanytsia Luhanska bridge were open, with people queueing to travel towards government-controlled areas at the EECP, and in both directions at the corresponding checkpoint. On 16 January, the SMM observed that the EECP was open but observed no civilians queuing in either direction.

On both days, the Mission noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoint of the armed formations south of the disengagement area near Zolote was closed.

#### Areas near the border outside government control<sup>6</sup>

On 15 January, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about an hour, the SMM observed 15 cars (including 13 with "DPR" plates), three buses (with "DPR" plates, carrying passengers of mixed genders and ages), and 17 people (ten men and six women of mixed ages, and one child) entering Ukraine. At the same time, it saw 27 cars (including 18 with "DPR" plates), three covered cargo trucks (with "DPR" plates), two buses (with "DPR" plates, carrying passengers of mixed genders and ages), and ten people (five women and five men of mixed ages) exiting Ukraine.

On the same day, while at a border crossing point near Ulianivske (61km south-east of Donetsk) for about 30 minutes, the Mission did not observe any traffic passing through.

On 15 January, the SMM also monitored areas close to the border with the Russian Federation near Kosharne (61km south-east of Donetsk), Vasylivka (65km south-east of Donetsk), Petropavlivka (68km south-east of Donetsk) and Stepne (72km south-east of Donetsk) and observed no change in the security situation.

The Mission continued monitoring in Kherson, Odessa, Ivano-Frankivsk, Lviv, Kharkiv, Dnipro, Chernivtsi and Kyiv.

### \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 4 January 2022). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denial:

- On 16 January, at a checkpoint near Staromykhailivka (non-government-controlled, 15km west of Donetsk), two visibly armed members of the armed formations denied the Mission passage west. While at the checkpoint, the SMM observed civilian traffic passing through.

- On the same day, at a checkpoint near Starolaspa (non-government-controlled, 51km south of Donetsk), a visibly armed member of the armed formations denied the SMM passage south into the settlement, citing "ongoing engineering activities" in the settlement.
- On the same day, at a checkpoint near Nova Marivka (non-government-controlled, 64km south of Donetsk), two visibly armed members of the armed formations denied the Mission passage into the settlement, citing "ongoing engineering activities" in the settlement and "the SMM's safety".

*Regular restrictions related to disengagement areas and mines/UXO:* 

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

#### Other impediments:<sup>7</sup>

- On 15 and 16 January, SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during 11 flights: three times while flying over areas near Mykolaivka (government-controlled, 40km south of Donetsk), twice each while flying over areas near Sentianivka (formerly Frunze, non-government-controlled, 44km west of Luhansk) and Vesele (government-controlled, 21km north of Donetsk), and once each while flying over areas near Oleksandro-Kalynove (government-controlled, 47km north of Donetsk), Kalynove (government-controlled, 35km north of Donetsk), Pionerske (government-controlled, 101km south of Donetsk) and Pervomaisk (non-government-controlled, 58km west of Luhansk).

(In red: a forward patrol base from which SMM staff have temporarily relocated based on recommendations of security experts from participating States, as well as SMM security considerations. The SMM uses the premises during daylight hours and also patrols in this settlement during daylight hours).
