STATEMENT BY THE DELEGATION OF SPAIN

On 10 October, we celebrate World Day Against the Death Penalty and, since 2007, European Day Against the Death Penalty. On the occasion of the 17th World Day Against the Death Penalty, the Government of Spain reiterates its opposition to capital punishment.

Mr. Chairperson,

Spain aligns itself with the statement made by the European Union on the World Day Against the Death Penalty. At the same time, we should like to make the following statement.

A global trend towards the abolition of the death penalty has been observed for decades. At present, more than two thirds of countries do not apply the death penalty.

The fight against the death penalty will continue to be a priority of Spanish foreign policy, together with the other countries of the European Union and the 22 countries that make up the Support Group of the International Commission against the Death Penalty. The Spanish Government will continue to urge the governments of the retentionist States to restrict the cases in which the death penalty is applied and impose moratoriums with a view to its definitive abolition. Likewise, it will urge those countries that have introduced draft laws reinstating the death penalty to withdraw them and maintain abolition, thus respecting the absolute human right to life.

Spain participated in the seventh World Congress Against the Death Penalty, which took place in Brussels in February this year. In December 2018, 121 United Nations Member States voted in favour of the General Assembly resolution on a moratorium. The Spanish Government will continue to promote abolition in multilateral forums, particularly as a current member of the United Nations Human Rights Council.

Spain will continue to support the International Commission against the Death Penalty, based in Madrid and founded in 2010 on the initiative of the Spanish Government, and also multilateral and civil society initiatives towards universal abolition.
