STATEMENT BY THE DELEGATION OF SPAIN

Thank you, Mr. Chairperson,

I should like to inform you that on 5 March, as proposed by the Prime Minister, His Majesty the King of Spain issued a decree dissolving Parliament and calling a general election for 28 April.

In accordance with the Copenhagen Document of 1990 and the provisions of the Charter for European Security of 1999, the Government of Spain has invited the Office for Democratic Institutions and Human Rights (ODIHR) to observe this election.

An ODIHR Needs Assessment Mission travelled to Spain on Monday, 4 March, to prepare for observing the election.

I request that this statement be attached to the journal of the day.
