II. PARTICIPATION

- 1. Representatives of Algeria, Egypt, Israel, Morocco and Tunisia will be invited to attend and make written contributions to the seminar. 1
- 2. Representatives of Japan and the Republic of Korea will be invited to attend and make written contributions to the seminar. Representatives of Japan will also be invited to contribute to the discussions at the seminar.
- 3. Representatives of the OSCE Parliamentary Assembly will be invited to participate in and contribute to the seminar.
- 4. The following international organizations and institutions will be invited to participate in and contribute to the seminar: the United Nations, the Council of Europe, the United Nations Economic Commission for Europe, the North Atlantic Treaty Organization, the Western European Union, the Organisation for Economic Co-operation and Development, the International Bank for Reconstruction and Development, the European Bank for Reconstruction and Development, the European Investment Bank, the United Nations Educational, Scientific and Cultural Organization, as well as the Commonwealth of Independent States, the Council of the Baltic Sea States, the Black Sea Economic Co-operation, the Central European Initiative and the Barents Euro-Arctic Council.
- 5. Participating States are encouraged to include representatives of non-governmental organizations and of the academic and research community in their Delegation staff.

III. TIMETABLE AND OTHER ORGANIZATIONAL MODALITIES

- 1. The seminar will be held at the Hofburg in Vienna on 18 and 19 September 1995 under the Chairmanship of Hungary.
- 2. The seminar will be organized in four sessions.
- 3. Moderators for the workshops will be appointed by the Chair after appropriate consultations. Keynote speakers may be invited to open discussions.
- 4. On the basis of the discussion, the Chair will prepare a summary of the seminar, which will be presented to the Permanent Council for further follow-up.
- 5. The list of sub-items under the titles of the various Sessions in the 'Agenda' section of this Decision is only indicative.
- 6. Participants are invited to circulate their written contributions in advance, preferably at least one week before the opening of the seminar.
- 7. Participating States are requested, when deciding on the level and number of their participants, to take due account of the tasks of the seminar, as indicated in Chapter VII of the Budapest Decisions, and of the objective of genuine dialogue.

This is in view of the fact that a special meeting in October of the Contact Group with non-participating Mediterranean States will be devoted specifically to a discussion on the emerging security model.

- 8. There will be no nameplates at the workshops.
- 9. There will be simultaneous interpretation at the sessions into the six official OSCE languages.

10. The Secretariat will, in consultation with the Chairmanship, arrange for appropriate media coverage of the seminar.

<u>Interpretative statement under paragraph 79 (Chapter 6) of the Final Recommendations of the Helsinki Consultations</u>

By the delegation of Malta:

'The delegation of Malta wishes to make an interpretative statement to be duly registered in the Journal of the day, concerning the decision on the 'Agenda and Organizational Modalities of the Seminar on a Common and Comprehensive Security Model for the Twenty-First Century'.

The delegation of Malta considers the decision just adopted as not changing, or creating any negative precedent affecting the established practice whereby Algeria, Egypt, Israel, Morocco and Tunisia may continue to be invited and to make oral contributions to seminars and other ad hoc meetings on subjects in which they have a special interest. These Mediterranean States have participated and verbally contributed to CSCE/OSCE seminars in the past and they may be invited to participate and to contribute verbally to other seminars in the future.'
