Water governance in the OSCE area – increasing security and stability through co-operation

Opening session

Mr. Moderator,

First of all, allow us to thank the OSCE Chairperson-in-Office, First Deputy Prime Minister and Minister of Foreign Affairs of Serbia Ivica Dačić, the Head of the Swiss Federal Department of Foreign Affairs Didier Burkhalter, Deputy Minister of Foreign Affairs of the Czech Republic Jakub Kulhánek, the OSCE Secretary General Lamberto Zannier and the Co-ordinator of OSCE Economic and Environmental Activities Yurdakul Yigitgüden for their informative statements.

We should also like to thank the Serbian Chairmanship and the Office of the Co-ordinator of OSCE Economic and Environmental Activities for their wonderful organization of this Forum, as well as the Czech authorities for their traditional hospitality.

Social and economic development and protection of the environment, including effective water use, have a direct impact on all of us, as well as our quality of life and well-being. Additional efforts by the OSCE in these areas could make a real, practical contribution to the sustainable development and stability of our countries.

We hope that the work of the current Forum will encourage further strengthening of co-operation between participating States and become an important milestone in the preparations for the OSCE Ministerial Council meeting in Belgrade in December.

In conclusion, allow us to wish all participants interesting and fruitful discussions.
