OSCE Security Days Event, 16 September 2013, Hofburg, Vienna

THE EVENT:

Launched in 2012 at the initiative of the Secretary General Lamberto Zannier, the Security Days is a forum for dialogue on the current and future role of the OSCE as a security organization. It is a valuable opportunity for practitioners, experts, representatives of civil society and delegates to engage with panellists in an interactive discussion both on the challenges the OSCE faces in addressing current security threats and on the role of civil society in shaping a security community.

This Security Days event will provide a platform for discussion on conflict resolution and peace enhancement tools. It will focus on conceptual and practical approaches in order to identify where further work should be taken forward as regards OSCE conflict resolution efforts and related aspects. The aim is to optimize the Organization's comparative advantages while taking account of the role and contributions of other international/regional organizations as well as lessons learned and best practices.

Drawing on examples from the OSCE area and beyond, the panel will consider what and how further work should be taken forward by the Organization in the area of conflict resolution, in particular with the aim to optimize the OSCE's comparative advantages vis-à-vis the role and contributions of other international/regional organizations.

This panel will explore tools that are and could be used in conflict resolution in an OSCE setting, such as dialogue facilitation and mediation (track one and track two), preventive diplomacy (as employed by the OSCE's High Commissioner on National Minorities) conciliation and arbitration, peace agreements and mechanisms to monitor and to provide guarantees for their implementation as well as non-military CBMs. Taking into account lessons learned and best practices, the panel will consider whether the current toolbox

needs strengthening and/or new tools should be developed to complement those that exist.

Taking account of the 1992 Helsinki Document, the main framework for possible OSCE peacekeeping operations, as well as other OSCE documents related to peacekeeping, including the 1993 Rome Ministerial Document (Chapter II), the 1999 Charter for European Security and the letter on peacekeeping from the Chairperson of the Permanent Council to the Chairman-in-Office (Appendix 13 of the journal of the Eleventh MC in Maastricht), this panel will review actual or potential contributions of regional/multilateral organizations to peacekeeping. In close conjunction with on-going debates on future peacekeeping operations, the panel will consider what the planning, establishment and running of military and civilian peacekeeping components could entail and how future operations could meet the challenge of an increasingly complex set of actors and dynamics on the ground.

Mindful that the likelihood of returning to violence may be reduced through the established of preventive structures, this panel will look into effective mechanisms for sustainable non-violent conflict resolution. The panel will in particular explore the potential added value of enhancing infrastructures for peace, a dynamic network of interdependent structures, mechanisms and resources linking both state actors as well as civil society institutions. In the same context, the panel will consider approaches to post-conflict rehabilitation that should have near-term prominence in the aftermath of conflict resolution, including but not limited to providing basic security, delivering peace dividends, shoring up and building confidence in the political process and strengthening core national capacity to lead peace building efforts. The potential contribution of reconciliation initiatives to peace building will also be part of the discussion.
