STATEMENT BY THE DELEGATION OF SAN MARINO

Mr. Chairperson,

I have the honour to take the floor to inform the Permanent Council of the message sent by Their Excellencies the Captains Regent of the Republic of San Marino to His Excellency the President of Bosnia and Herzegovina, Mladen Ivanić, on the occasion of the 20th anniversary of the Srebrenica genocide, to express the sentiments of fraternal closeness and heartfelt solidarity to all the people of Bosnia and Herzegovina, so sorely tried by the worst war crime committed in Europe since the end of the Second World War.

Faced with the recent phenomena of a resurgence of hatred and barbarism, we believe that it is necessary for us all to continue, firmly and unequivocally, to raise our voices to defend those inalienable values of mutual respect, tolerance, rejection of hatred and of violence, and solidarity, which underpin civilized and peaceful coexistence and our own European identity.

In this spirit and with the understanding that remembrance may constitute a warning for our future, the Grand and General Council of this ancient Republic (Parliament) adopted on 24 April an agenda to reaffirm our country's commitment to play an active and vigilant role in defending inviolable human rights and to dedicate the International Day of Peace, which is celebrated on 21 September, to the memory of all genocides wherever they have been perpetrated.

I would ask you to attach this statement to the journal of the day.

I. Indicative agenda

Introduction

Ministers for foreign affairs have noted in Basel that recent and ongoing international developments provide ample evidence that the security of the OSCE area is inextricably linked to that of adjacent areas, including the Mediterranean as a whole. They also noted that changes unfolding in the Mediterranean region reflect a profound and complex process that may have enormous consequences for security in the OSCE region and beyond. These changes open up opportunities for development and co-operation and also increase the range of diverse and complex challenges, many of which are transnational in nature.

The 2015 OSCE Mediterranean Conference will therefore be devoted to "Common security in the Mediterranean region – challenges and opportunities" and will have a cross-dimensional approach in its entirety, not only consistent with the OSCE's comprehensive approach to security, but also highlighting the fortieth anniversary of the Helsinki Final Act and its Mediterranean chapter.

The first session shall allow a broader, political discussion and is aiming at high-level participation, subsequently followed by three thematic sessions addressing common current challenges for OSCE participating States and Partners for Co-operation.

The Conference will provide opportunities for the sharing of views and experiences among the OSCE participating States and Mediterranean Partners in view of identifying avenues for a forward looking dialogue and concrete co-operation.

The OSCE Mediterranean Conference 2015 can reaffirm our strong belief in the relevance and the value of the OSCE Mediterranean Partnership and contribute to further strengthening dialogue and co-operation of OSCE and Mediterranean Partners for Co-operation.

Representatives of non-governmental organizations will be able to attend and contribute to the Conference in accordance with the relevant OSCE provisions and practices (advance registration required).

Other countries and organizations may be invited by the host country to observe the conference.

III. Organizational modalities

The Conference will begin at 9 a.m. (opening remarks) on the first day, and end at 1 p.m. on the second day.

Each session will have a moderator and a rapporteur appointed by the Chairperson. The consolidated summary will be forwarded to the Permanent Council for further consideration.

Appropriate arrangements for press coverage will be made.

The working language will be English. At the request of several participating States and Partners for Co-operation interpretation will be provided from and into French. These arrangements will not constitute a precedent that can be relied upon in other circumstances.

The Rules of Procedure of the OSCE will be followed, *mutatis mutandis*, at the Conference. Also, the guidelines for organizing OSCE meetings (Permanent Council Decision No. 762) will be taken in account.
