STATEMENT BY THE DELEGATION OF GEORGIA

Mr. Chairman,

My Delegation has more than once reiterated its position with regard to the Border Monitoring Operation (BMO) along the Georgian-Russian border. Let me once again express our firm support for this serious endeavour and thank the OSCE for its continued commitment to establishing lasting peace and stability in Georgia and in the region as a whole.

The BMO has played a key role in mitigating tensions at the Chechen segment of the Georgian-Russian border and has prevented the spillover of conflict into the territory of my country. The BMO has clearly contributed to the establishment of fruitful and constructive relations between the border services of the Russian Federation and those of Georgia and has rendered substantial assistance to the Georgian border guards.

At a time of heightened tension on the Georgian-Russian border, the OSCE BMO has played a central role in keeping the international community posted on the real situation in the area, and is largely considered a success. More to the point, we see the BMO as a unique initiative in the whole OSCE area and believe that its effective realization may serve as a tool for solving problems concerning international borders. We cannot accept the blunt criticism of some addressed to the BMO. During the month of June of this year alone (1, 2, 12, 13, 14 and 23), the BMO registered six cases of illegal movement by camouflaged persons. On 7 June the BMO registered the violation of Georgian airspace by an unidentified helicopter. All this clearly indicates the effectiveness of the ongoing operation. It is no surprise that an operation of such magnitude may have certain shortcomings, but we are strongly confident that on the whole the BMO has made a serious contribution to the restoration of stability in the region. We tend to believe that in close co-operation with international experts, the Georgian side could work out some alternative options to the adapted mandate of the Operation and submit them for consideration.

Proceeding from the above-mentioned we give our full support to the extension of its mandate for six months and once again would like to thank the Organization for this important initiative.

In closing, Mr. Chairman, I would be grateful if you would kindly have the text of this statement attached to the Journal of the Day.

Taking into account the recommendation of the Permanent Council,

Decides to extend the mandate of Mr. Rolf Ekéus as OSCE High Commissioner on National Minorities for a period of three years with effect from 1 July 2004.

Recalling its Decision No. 586 of 18 December 2003, concerning the extension of the mandate of the border monitoring operation of the OSCE Mission to Georgia,

Further recalling the report pursuant to Decision No. 586 of the Permanent Council of 18 December 2003, on the activities of the border monitoring operation of the OSCE Mission to Georgia, its Decision No. 590 of 24 December 2003 on the 2004 Unified Budget, in which funds for the operations of the border monitoring operation of the OSCE Mission to Georgia were allocated for the whole of 2004, as well as the different views on the activities of the ongoing operation expressed in the Preparatory Committee meeting on 15 June 2004,

Decides to extend the mandate of the border monitoring operation of the OSCE Mission to Georgia until 31 December 2004.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH 79 (CHAPTER 6) OF THE FINAL RECOMMENDATIONS OF THE HELSINKI CONSULTATIONS/Corrected reissue*

By the Delegation of the Russian Federation:

"The Russian delegation has joined the consensus with regard to the decision adopted by the Permanent Council on the extension of the mandate of the OSCE monitoring operation on the Georgian-Russian border until 31 December 2004 on the understanding that this is the last decision of this kind and that as of 1 January 2005 the OSCE monitoring operation on the Georgian-Russian border will cease. The Russian Federation takes this position, first and foremost, in the light of the radically new conditions that have arisen in this region in comparison to 1999 when the operation was begun. The qualitative improvement of the situation on the Georgian-Russian border, positive developments in the normalization of the situation in the Chechen Republic of the Russian Federation and substantial progress in the strengthening of co-operation between the Russian and Georgian border services make it possible to find an effective solution to the problem of guarding this segment of the State border using Russia's and Georgia's own forces, without the involvement of the OSCE. Moreover, the practical gain from the monitoring has been negligible, something to which the Russian delegation has repeatedly drawn attention over the last few years. All these factors make the further continuation of this operation inappropriate.

In view of the fact that the closure of OSCE field operations requires a certain amount of time and the adoption of relevant administrative and financial decisions, we trust that the Secretariat, together with the OSCE Mission to Georgia, will begin work without delay on the elaboration of the necessary proposals for the financial and operational modalities for termination of the operation at the start of the winter session and its subsequent complete closure as of 1 January 2005.

We request that this statement be attached to the decision adopted and the Journal of the day."

Recalling Decision No. 590 of 24 December 2003 on the year 2004 Unified Budget,

Takes note of the supplementary budget proposal proposed under PC.ACMF/48/04/Rev.1 of 4 June 2004;

Approves the supplementary budget in the amount of EUR 473,600 under the Operational Costs Cost Category as contained in the attached Annex, bringing the total Unified Budget to the amount of EUR 180,785,700;

Determines that this supplementary budget shall, in principle, be financed from the savings and reallocations, to the extent possible, from the Secretariat and/or Institutions, such as they may be identified in the Mid-Year Review and/or the Year-End Review of the 2004 Unified Budget;

In order to ensure more cost-effective use of the financial, human and material resources, calls upon the ODIHR to make recommendations for the prioritization of its activities in the context of the 2005 Unified Budget discussions.
