DECISION No. 247

The Permanent Council,

Recalling Decision No. 232 (PC.DEC/232) of 11 June 1998 on the 1998 Mediterranean Seminar on "The Human Dimension of Security, Promoting Democracy and the Rule of Law" to be held in Valletta, Malta,

- Decides to change the dates of the 1998 Mediterranean Seminar from 28 and 29 October 1998 to 19 and 20 October 1998; and
- Adopts, after consultation with the participating States and the Mediterranean partners for co-operation, the agenda, timetable and organizational modalities of the Seminar as contained in the annex.

II. PARTICIPATION

- 1. The Mediterranean partners for co-operation (Algeria, Egypt, Israel, Jordan, Morocco, Tunisia) will attend all the sessions and make contributions to all the meetings.
- 2. Japan and the Republic of Korea will be invited to participate in and contribute to the Seminar.
- 3. The OSCE Parliamentary Assembly will be invited to participate in and contribute to the Seminar.
- 4. The following international organizations and institutions will be invited to participate in and contribute to the Seminar: European Commission; European Union/Barcelona Process; International Committee of the Red Cross; Mediterranean Forum; Organization of African Unity; Organization of the Islamic Conference; United Nations; United Nations High Commissioner for Human Rights; United Nations High Commissioner for Refugees; United Nations Educational, Scientific and Cultural Organization; United Nations Environment Programme; United Nations Economic Commission for Europe; Council of Europe; Parliamentary Assembly of the Council of Europe; the League of Arab States; North Atlantic Treaty Organization; Western European Union; Black Sea Economic Co-operation Council; Organisation for Economic Co-operation and Development; European Bank for Reconstruction and Development; as well as the Commonwealth of Independent States.
- 5. Representatives of non-governmental organizations will be able to attend and contribute to the Seminar in accordance with the relevant OSCE provisions and practices.

6. Other countries and organizations may be invited by the host country.

III. TIMETABLE AND OTHER ORGANIZATIONAL MODALITIES

- 1. The Seminar will begin at 9.30 a.m. (opening ceremony) on 19 October 1998 and end at 6.30 p.m. on 20 October 1998.
- 2. The opening and closing sessions will be chaired by a representative of the Chairman-in-Office.
- 3. Each session will have a moderator and rapporteur appointed by the Chair. The Consolidated Summary will be forwarded to the Permanent Council for further consideration.
- 4. Appropriate arrangements for press coverage will be made.
- 5. The working language will be English. At the request of several States interpretation will be provided from and into French. These arrangements will not constitute a precedent that can be relied upon in other circumstances.
- 6. Other rules of procedure and working methods of the OSCE will be applied, *mutatis mutandis*, to the Seminar.
- 7. Rooms for additional ad hoc meetings will be made available to participants. Such meetings will be held without interpretation.
- 8. Moderators and rapporteurs will be decided at a later stage.
- 9. For Session 4, key-note speakers invited to participate in the Seminar from a limited number of international organizations/institutions and key-note speakers from OSCE institutions will be identified at a later stage.
