STATEMENT BY THE DELEGATION OF CYPRUS

Mr. Chairperson,

The Permanent Mission of Cyprus to the OSCE would like to inform the Forum that the destruction of all obsolete and expired ammunition as described in the questionnaire of 2 November 2011 has been successfully completed. The destruction of 111,643 40 mm Bofors cartridges (770 tons) was carried out between September 2011 and 15 June 2012 and the destruction of 7,035 rounds of 81 mm mortar ammunition in the first semester of 2013, both with the open burning open detonation (OBOD) method and in accordance with all OSCE documents and other international norms.

Additionally, by process of tender evaluation, the contract for the destruction of 23,347 rounds of 60 mm mortar ammunition and of 33,356 rounds of 105 mm artillery ammunition has been granted by Cyprus's Ministry of Defence to a Spanish company, and for the destruction of 63,200 0.50 and 8,627,933 0.303 and 0.30 inch cartridges to a Cypriot company.

Furthermore, in accordance with a four-year "framework" contract concluded by the Cypriot Ministry of Defence with five private companies, in the future any obsolete or surplus ammunition will not remain in the National Guard's ammunition depots but will be transferred to the aforementioned companies for destruction within a period of time not exceeding 15 days from the date of the official request of the Ministry of Defence.

Finally, an ammunition laboratory equipped with the latest technology exclusively used for ammunition powder control has been established in the Republic of Cyprus. In addition, we are still continuing with the construction of new and the renovation of old ammunition storage sites.

Mr. Chairperson,

Once more, the delegation of Cyprus would like to ask you to convey our sincere thanks to the CPC Support Section and wishes to thank the participating States Bulgaria, France, Greece, Italy, Serbia, Slovenia, Spain, the United Kingdom and the United States of America for supporting the project of technical assistance and for assisting in the destruction of obsolete and expired ammunition in Cyprus.

I request that this statement be attached to the journal of the meeting.
