DECISION No. 17/07 MEASURES TO IMPROVE THE AVAILABILITY OF EXCHANGED FSC-RELATED INFORMATION

The Forum for Security Co-operation (FSC),

Recalling FSC Decision No. 2/02 (FSC.DEC/2/02) and its explanatory note (SEC.INF/35/02),

Recalling the importance of a timely and full implementation of all FSC-related information exchanges,

Noting that there is no decision that requires FSC-related information exchanges for all participating States also to be made available through the OSCE Documents Distribution Unit.

Recognizing the need to have all FSC-related information exchanges readily available in one place,

Decides that the participating States will also provide all relevant FSC-related information exchanges, as reflected in the "CPC Implementation Calendar", to the OSCE Documents Distribution Unit in an electronic format (preferably "doc" or "pdf" file) for further distribution. This will supplement and not replace current practice.
