DECISION No. 1206 DATES AND VENUE OF THE 2016 OSCE MEDITERRANEAN CONFERENCE

(Vienna, 5 and 6 October 2016)

The Permanent Council,

Welcoming the offer by the Republic of Austria to host the 2016 OSCE Mediterranean Conference, and further to discussions with the Mediterranean Partners for Co-operation,

- 1. Decides to hold the 2016 OSCE Mediterranean Conference, which could deal with issues related to youth, migration, and violent extremism, on 5 and 6 October 2016 in Austria;
- 2. Notes that the Conference is intended to start with a political segment in the afternoon of 5 October and will continue with discussions in separate sessions throughout 6 October;
- 3. Also decides that further details concerning the agenda, timetable and other organizational modalities for the Conference will be elaborated within the framework of the Mediterranean Contact Group and submitted to the Permanent Council for adoption.
