#### STATEMENT BY THE DELEGATION OF AZERBAIJAN

Mr. Chairperson,

On 10–11 June 2014, at the conference titled "OSCE and Human Right Defenders: the Budapest Document 20 years on" held in Bern, the Director of the ODIHR, instead of emphasizing and describing the importance of this occasion, attempted to lodge ungrounded accusations against the Government of Azerbaijan.

Opening remarks delivered by the Director of ODIHR at the event organized jointly with the Swiss Chairmanship were dedicated mainly to the case of Mr. Anar Mammadli, as if the event was not about the Budapest Document, but on Azerbaijan.

Our delegation expresses its deep regret that Ambassador Lenarčič once again demonstrated a lack of professional approach in his capacity of the Director of the ODIHR and rather opted for pursuing his personal interests in an emotional manner.

Such a position taken by the Director of the ODIHR against the OSCE participating State, which lacks objectivity, not corresponding to the title of session and attempting to portray an individual case as a main subject of the event, undermines limited trust remaining to him.

#### Mr. Chairperson,

We would not have raised this issue at the meeting of the Permanent Council, if it is not for the second time during this month that we officially register our concerns to the Swiss Chairmanship over the actions of Ambassador Lenarčič. While duly respecting the autonomy of this institution, our delegation again requests the Chairmanship to ensure that the ODIHR Director acts in accordance with his mandate in an impartial manner.

Our delegation hopes to receive a response from the Swiss Chairmanship on the course of actions they plan to take to address an increasing concern by the OSCE participating State.

Actions of the Director of the ODIHR raise a reasonable question as to how to ensure that a proper system of checks and balances in the OSCE will allow OSCE participating States, which delegated an authority to OSCE official, to timely and effectively prevent an

abuse of mandate. Our delegation expects the Chairmanship to substantively address this issue in the course of "Helsinki+40" process.
