# Introduction

The war against Ukraine has generated a significant humanitarian crisis in the European continent and beyond, with millions of people fleeing their homes in search for safety and protection abroad or in other parts of the country.<sup>1</sup>

Most participating States of the Organization for Security and Co-operation in Europe (OSCE) have responded to the crisis with unprecedented solidarity, putting in place swift legislative and policy measures to grant refugees protection in their territories, as well as access to a wide array of assistance and support services, with a view to facilitating their stay into the host communities.

With the overwhelming majority of refugees being women and children (87%)<sup>2</sup>, vulnerabilities and risks for exploitation and abuse for those fleeing the war have been an urgent concern of governments and international actors. Risks of trafficking in human beings (THB), in particular, are deemed extremely high. For example, data gathered by the Office of the OSCE Special Representative on Combating Trafficking in Human Beings (OSR/CTHB) and Thomson Reuters shows that global internet search traffic for sexual services by Ukrainian women increased between 200%-600% in some States since the start of the humanitarian crisis.<sup>3</sup> Such data demonstrates, at a minimum, that demand for sexual services exists, which can in turn serve as a strong incentive for traffickers to recruit and exploit Ukrainian women and children at scale.

Humanitarian actors and first line responders working to provide reception and relief to incoming refugees might not necessarily be appropriately equipped to recognize specific risks and indicators of human trafficking, to identify potential victims amongst the arrivals, and to refer them to the relevant authorities for the provision of necessary assistance. Furthermore, the specific traumas linked to trafficking-related experiences, as well as those generated by the crisis itself, require responders to have a particular understanding and skills in approaching potential victims in a trauma-informed, gender-sensitive and age-appropriate manner. The ever-evolving and adaptable modus operandi of traffickers in terms of targeting, recruiting and exploiting their victims in the context of the crises poses additional challenges to authorities, who need to be able to identify new patterns and traffickers' recruiting strategies at fast pace.

Capacity-building of relevant stakeholders, and particularly of those working on the front lines of the humanitarian crisis, is thus a key component of participating States' anti-trafficking response in the context of the crisis. With a view to supporting counterparts to minimize risks of THB and work pro-actively to identify and assist victims, several international and non-governmental organizations (IOs and NGOs) have developed and are providing a number of training opportunities.

The OSR/CTHB, through this resource, aims to facilitate access of related actors to such opportunities by compiling trainings and modules - that are readily available to or can be requested by authorities and organizations operating on the ground - on a number of issues connected with addressing trafficking in human beings in the context of the humanitarian crisis generated by the war against Ukraine. Courses in this compilation include webinars, self-paced online modules, in-person trainings and blended exercises, with related details concerning their geographical focus, target audience, duration, learning objectives and access modalities.

Amongst the trainings included in this resource, there are both courses that are specifically tailored to the current context and contain related components/elements, as well as anti-trafficking courses of a more general nature, which can nevertheless directly benefit different sets of stakeholders working to respond to the crisis.

The training courses in this compendium are organized thematically, in order to ease understanding of the training offer. An index by topic, as well as one by target audience are included to further facilitate readers' navigation of the resource.

This compilation was developed as part of the OSCE OSR/CTHB project "*Preventing and responding to trafficking in human beings amid the humanitarian crisis related to the war in Ukraine*", offering technical assistance and policy support to participating States on preventing and countering THB in the context of the war against Ukraine.
