# DECISION No. 1479 RECOMMENDATION TO ADOPT A DECISION ON THE TIME AND PLACE OF THE NEXT MEETING OF THE OSCE MINISTERIAL COUNCIL

The Permanent Council,

- 1. Requests the Chairperson of the Permanent Council to transmit to the Chairperson-in-Office the draft decision of the Ministerial Council on the time and place of the next meeting of the OSCE Ministerial Council (MC.DD/1/24 of 22 February 2024);
- 2. Recommends to the Ministerial Council the adoption of this decision through a silence procedure with the period of silence expiring on 6 March 2024, at noon CET.
