# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Belarus (also on behalf of the Russian Federation):

"In connection with the Permanent Council decision adopted regarding the agenda for the 2011 OSCE Human Dimension Implementation Meeting, we should like to make the following statement.

In a spirit of compromise and in the interests of the Organization, the delegation of the Republic of Belarus and the delegation of the Russian Federation have joined the consensus on the decision regarding the agenda for the 2011 OSCE Human Dimension Implementation Meeting, despite the fact that this decision does not fully take into account the position of our countries as regards the aforementioned OSCE event and, in particular, its duration.

We are firmly convinced that the OSCE Human Dimension Implementation Meeting could be held effectively and in a high-quality manner in a more condensed period of time without detriment to its thematic content and results, as was recommended in the report by the Panel of Eminent Persons in 2005.

The Republic of Belarus and the Russian Federation believe it necessary, in accordance with OSCE Permanent Council Decision No. 476, to begin substantive work without delay on revising and optimizing the modalities for holding OSCE human dimension meetings, including questions concerning their duration, the participation of non-governmental organizations and ensuring that they are fully in accordance with the Rules of Procedure of the OSCE. Over the last few years, including within the framework of the Corfu Process, the delegations of the two countries made quite a number of specific proposals aimed at making events in the third basket more effective and attractive. These proposals continue to be relevant and remain on the negotiating table.

In this connection, we welcome the Lithuanian Chairmanship's intention to organize a comprehensive and productive discussion on improving the organization and modalities of OSCE human dimension meetings, the assurances given by the Irish OSCE Chairmanship for 2012 as regards ensuring continuity in this work and the declared readiness of other participating States to engage in open, constructive and substantive dialogue on this subject.

We assume that specific decisions on improving the modalities for holding OSCE human dimension meetings will be agreed upon and approved by the Permanent Council prior to the start of consultations on the time-frame and themes of key OSCE events in the human dimension in 2012.

We would ask that this interpretative statement be attached to the decision adopted, and included in the journal of today's meeting of the Permanent Council."
