# STATEMENT BY THE DELEGATION OF AUSTRALIA (PARTNER FOR CO-OPERATION)

Thank you, Mr. Chairperson.

The Australian delegation would like to echo the comments made by colleagues from the Netherlands, the European Union, the United States of America, Canada, Belgium, the United Kingdom, Norway and Ukraine. Australia thanks the Netherlands and the Dutch Safety Board for leading the aircraft accident investigation, for bringing its report to the attention of the Permanent Council, and for subsequent clarifications made just now by the Dutch Ambassador. The Dutch Safety Board's report is the result of a meticulous forensic investigation. It has been prepared in accordance with Annex 13 to the Convention on International Civil Aviation following an extensive independent civil investigation in accordance with International Civil Aviation Organization (ICAO) requirements.

With regard to comments made by the Russian delegation, I note that a number of countries, including Australia and Russia, participated in the Dutch Safety Board led international investigation conducted in consultation with the ICAO, and in accordance with ICAO rules and guidelines.

The Dutch Safety Board's findings are based on an objective analysis of available evidence. The report concludes that flight MH17 was downed by a BUK surface-to-air missile. Regarding comments by the Russian delegation, I note that the report deals with a range of theories as to what happened, including those put forward by Russia, and specifically considers and rules out other possible causes.

Mr. Chairperson,

Australia continues to grieve for all 298 people on board, including those who called Australia home. Today, our thoughts are with the families and loved ones as they deal with the findings of the Dutch Safety Board's report. We should never forget the families of the victims.

Australia, together with other countries represented on the Joint Investigation Team (Belgium, Malaysia, the Netherlands and Ukraine), is committed to ensuring that UN Security Council resolution 2166's demand for accountability is implemented in full. We are

deeply conscious that the families and friends of the victims of MH17 around the world are anxious for information about the criminal investigation and possible prosecutions.

We are committed to completing the criminal investigation as expeditiously as possible without compromising its integrity.

We are also carefully considering the available prosecution options in order to prepare for the most effective prosecution mechanism.

In closing, I would like to reiterate Australia's appreciation to the OSCE and the Special Monitoring Mission for their assistance in facilitating access to the site following the tragedy.

I request that this statement by included in the journal of the day.

#### STATEMENT BY THE DELEGATION OF ROMANIA

Mr. Chairperson,

I would like to inform the Permanent Council that Romania marked on 9 October the National Day on Holocaust Remembrance. On this occasion, the Minister of Foreign Affairs of Romania, Mr. Bogdan Aurescu, said the following:

"By remembering the victims of the Holocaust in Romania, we mark the beginning and not the end of our responsibilities in dealing with the recent history, so that the tragedy of the victims of the Holocaust will never repeat again. The Ministry of Foreign Affairs of Romania fully supports the efforts to educate the young generation in the spirit of respecting human rights and fundamental freedoms, so that it understands the consequences of any discriminatory, anti-Semitic or racist action.

The anniversary of 9 October marks the conscious and sincere acknowledgement of a painful episode in our national history. The National Day on Holocaust Remembrance is a moment of contemplation for us all, an opportunity to reflect on the tragic consequences of extremist manifestations on community relationships, human values, democracy, and on respecting human rights.

The Holocaust remembrance will be one of the main issue to be addressed within the debates of the International Holocaust Remembrance Alliance – IHRA, whose Chairmanship will be taken over by Romania in 2016. By appointing Romania to take over the Presidency of the Organization, the efforts made by the Romanian authorities to preserve the memory of the Holocaust through the legal and administrative instruments developed on a national and local level, including through collaboration with the civil society and Jewish organizations, are being recognized."

Minister Aurescu stressed that "Romania will significantly contribute to the fulfilment of the Alliance's mandate to promote education, commemoration and research of the Holocaust."

Let me reiterate Romania's determination to further contribute through diplomatic means to strengthening the legal and institutional instruments meant at sanctioning anti-Semitism, as well as any other racist, xenophobic, discriminative and intolerant manifestations, in conformity with its OSCE commitments.

I would like to kindly request to attach this statement to the journal of the day.
