In accordance with the Ministerial Council Decision 7/13 and the 2013 Addendum to the OSCE Action Plan to Combat Trafficking in Human Beings, the OSCE recognizes the importance of taking appropriate action on a national and international level to tackle current and emerging trends and patterns in trafficking in human beings (THB). In today's modern world, information and communications technology (ICT) is at the forefront of human trafficking discussions. Like all tools, technology can and is being used for both negative and positive purposes. While traffickers are using technology to recruit and control victims, profit from exploitation, and expand the illicit marketplace, technologies are also increasingly being used to prevent exploitation, protect victims and assist in holding traffickers accountable.

The *19th Alliance against Trafficking in Persons* conference will focus on how technology is being misused to facilitate trafficking, and how it can be developed, harmonized and deployed to help combat all forms of trafficking. This event will provide a platform within the context of technology for participants to identify, discuss and develop opportunities across all four "Ps" of the OSCE's response to human trafficking: prevention, prosecution, protection and partnership.

In this regard, a special emphasis will be put on ICT developments that can be used by multiple stakeholders — including law enforcement, analysts, social service providers, and NGOs — in order to maximize their scalability and impact through a more coordinated approach. The debate will also focus on exploring how national legal and institutional frameworks can be adjusted in support of this effort.

In conclusion, the Alliance Conference will focus on strategies for ending the misuse of technology to facilitate trafficking and promoting cooperative measures for utilizing ICT to combat trafficking. Throughout the conference, efforts will be made to further promote the full and effective implementation of relevant OSCE commitments including the *2013 Addendum to the OSCE Action Plan to Combat Trafficking in Human Beings: One Decade Later* (PC.DEC/1107/Corr.1), and relevant Ministerial Council Decisions, namely *Combating Sexual Exploitation of Children* (MC.DEC/15/06) and *Strengthening Efforts to Combat All Forms of Child Trafficking, Including for Sexual Exploitation, as well as other Forms of Sexual Exploitation of Children* (MC.DEC/7/17) as well as regional and international obligations.
