The Chairperson, the Netherlands-European Union, the United States of America (PC.DEL/856/16), Switzerland, the Russian Federation, Turkmenistan, Georgia, Kyrgyzstan, Uzbekistan, Belarus, the Holy See, San Marino, Ukraine, Canada, Norway, Mongolia, Serbia, Armenia, Liechtenstein, Montenegro, Moldova, Azerbaijan and Bosnia and Herzegovina extended their condolences to the families of the victims of the attacks in Aktobe, Kazakhstan, on 5 June 2016, and in Istanbul, Turkey, on 7 June 2016.
