INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of France:

"The French delegation would like to make the following interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure.

The decision on the timetable of the Twenty-Third Meeting of the OSCE Ministerial Council does not set a precedent for the organization of subsequent Ministerial Councils of the Organization.

We recall that paragraph IV.2(B)2 of the Rules of Procedure of the OSCE stipulates that 'The decision on the timetable and organizational modalities for each Ministerial Council meeting shall be adopted by the Permanent Council not later than one month before the meeting.'"

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Thank you, Mr. Chairperson.

In accordance with the relevant portion of the OSCE Rules of Procedure my delegation would like to make the following interpretative statement:

For most of us it is self-evident that our meetings should be conducted according to the Rules of Procedure.

We therefore interpret the addition to this decision of the language referencing the OSCE Rules of Procedure as necessary for only one delegation which needed to remind itself to follow the Rules of Procedure.
