# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation (also on behalf of Belarus):

"In connection with the adoption by the Permanent Council of the decisions on the topics and dates of OSCE human dimension events in 2010, the delegations of the Russian Federation and the Republic of Belarus would like to make the following interpretative statement.

In joining the consensus on the decision on the dates of the Human Dimension Implementation Meeting, the Russian Federation and the Republic of Belarus assume that in line with Permanent Council Decision No. 476 of 23 May 2002 on the modalities for OSCE meetings on human dimension issues (paragraph I.1 of Annex 1), the Warsaw Human Dimension Implementation Meeting will not be held if a decision is adopted to hold a Review Conference. Our delegations will be guided by this position in the process of reaching agreement on the Permanent Council decisions concerning the holding of the Warsaw meeting or a Review Conference.

We also trust that the Chairmanship will organize under its aegis in 2010 an event devoted to freedom of movement and the liberalization of visa regimes.

We ask that this interpretative statement be attached to the decision on the dates of the Human Dimension Implementation Meeting and to the journal of today's meeting."
