11:30 - 12:45 Panel 2: Recruitment and representation of national minorities in police services in order to improve operational practices, trust and accountability when preventing and managing conflict.

This panel will review the possibilities for, and impediments to, achieving a balanced composition of the police services; one that reflects the diversity of the society that they serve by ensuring the adequate representation of national minorities, including women. The panel will identify practices that have so far proven successful in attracting candidates from all sections of society. It will also look into the aspects of **community policing** by addressing and exploring the factors of trust and communication with the communities the police services serve. The panel will elaborate on measures that the States can take to create an enabling environment with reliable accountability mechanisms. Finally, the panel will review different policies and measures that ensure that the police and the public, including minorities, understand the role of the police in promoting good inter-ethnic relations and which ensure that the police are tasked and equipped to carry out this role.

**14:15 - 15:30 Panel 3:** *Gender responsive approaches to policing: barriers and opportunities in mainstreaming gender (and minorities) in police services.*
