# STATEMENT BY THE DELEGATION OF THE UNITED KINGDGOM

Mr. Chairperson,

On 15 June 2010 the UK Government published the report of The Tribunal of Inquiry into the events of Bloody Sunday, chaired by Lord Saville. The Inquiry examined the circumstances of Sunday 30 January 1972, in which soldiers opened fire on demonstrators at a civil rights march in Londonderry, killing 13 people on the day and wounding more, including one who later died.
