LETTER FROM THE MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF MONTENEGRO TO THE CHAIRMAN-IN-OFFICE OF THE OSCE

Podgorica, 4 June 2006

Your Excellency,

I have the honour to inform you that the Republic of Montenegro is ready to join the Organization for Security and Co-operation in Europe (OSCE) as a participating State.

The Government of the Republic of Montenegro hereby adopts the Helsinki Final Act, the Charter of Paris for a New Europe, the Charter for European Security, and all other OSCE documents.

The Government of the Republic of Montenegro accepts in their entirety all the commitments and responsibilities contained in those documents, and declares its determination to act in accordance with the provisions contained therein.

The Government of the Republic of Montenegro expresses its commitment to all OSCE principles and standards, and its readiness to actively co-operate with all OSCE participating States in the pursuit of the goals of this Organization.

The Government of the Republic of Montenegro expresses readiness to adopt and apply all the provisions of the Vienna Document on Confidence- and Security-Building Measures, including giving full effect to the rules of transparency, predictability and conflict prevention.

The Government of the Republic of Montenegro takes this opportunity to express its strong interest to host a full-fledged OSCE Mission.

H.E. Mr. Karel De Gucht Chairman-in-Office of the OSCE Minister of Foreign Affairs of Belgium Brussels The Government of the Republic of Montenegro expresses its readiness to sign the Helsinki Final Act and the Charter of Paris for a New Europe by the Head of State or Government of the Republic of Montenegro at the earliest convenience.

I kindly ask you, Your Excellency, to circulate copies of this letter to all OSCE participating States.

Please accept, Your Excellency, the assurances of my highest consideration.
