# STATEMENT BY THE DELEGATIONS OF THE RUSSIAN FEDERATION AND THE UNITED STATES OF AMERICA

## **Global Initiative to Combat Nuclear Terrorism**

Recognizing the gravity of the threat of acts of nuclear terrorism, Russia and the United States announced on 15 July 2006 the Global Initiative to Combat Nuclear Terrorism. It is a voluntary Initiative aimed at developing partnership capacity to combat nuclear terrorism on a determined and systematic basis. The Global Initiative is proof of our commitment to take necessary steps, together with our partners, to:

- Improve accounting, control and physical protection for nuclear and radiological material;
- Enhance security at civilian nuclear facilities;
- Improve detection of nuclear and radiological materials to prevent illicit trafficking;
- Improve capability to search and confiscate unlawfully held nuclear material and establish safe control over unlawfully held material;
- Prevent safe haven to terrorists and, financial/economic resources to stop acquisition and use of nuclear and radiological materials;
- Improve national legal frameworks to ensure criminal and civil liability for terrorists who commit acts of nuclear terrorism;
- Improve capabilities of participants for response, mitigation, and investigation, in cases of terrorist attacks involving the use of nuclear and other radioactive materials; and
- Promote greater information sharing on acts of nuclear terror.

The Initiative is consistent with objectives set forth in the International Convention for the Suppression of Acts of Nuclear Terrorism, Convention on the Physical Protection of Nuclear Material and Nuclear Facilities, and its 2005 amendment, and other international instruments related to combating nuclear terrorism. A main objective of the Initiative is also to mobilize states to implement obligations under the mentioned international instruments. The activities within the framework of the Initiative are to be undertaken consistent with international legal frameworks and national legal authorities.

Global Initiative partners have endorsed the Statement of Principles. Current partners include Afghanistan, Armenia, Australia, Cambodia, Canada, China, France, Germany, Greece, Israel, Italy, Japan, Kazakhstan, Macedonia, Morocco, Palau, Romania, Russian Federation, Sri Lanka, Turkey, Ukraine, United Kingdom, and the United States. Two meetings were held, the first in Morocco and the second in Turkey, at which a Plan of Work for 2007–2008 was developed. A third meeting will take place this June in Kazakhstan to welcome new partners and further refine the Plan of Work.

All partner nations agree that the Global Initiative is open to other nations who are actively committed to combating nuclear terrorism on a determined and systematic basis and who endorse the Statement of Principles. Any OSCE participating State that desires to join the Initiative is requested to publicly endorse the Statement of Principles and forward a written endorsement to the Russian Federation and/or to the United States, the Co-Chairs of the Initiative.
