STATEMENT BY THE DELEGATION OF KYRGYZSTAN

Mr. Chairperson, Distinguished members of the Permanent Council,

Taking into account the importance of ensuring freedom of speech and the human right to self-expression as a key element in the development of democracy, and also acting exclusively in the interests of consensus and with a view to the continued operation of an important OSCE institution, the Kyrgyz Republic, despite its principled opinion of Ms. Dunja Mijatović, has taken the decision to support the extension of the mandate of the OSCE Representative on Freedom of the Media by one year.

Kyrgyzstan respects the mandate of the OSCE Representative on Freedom of the Media. At the same time, we should like to underscore and remind Ms. Mijatović of the high level of responsibility of the position of the OSCE Representative on Freedom of the Media. Impartiality and objectivity are important aspects of the Representative's work. Unfortunately, we have not always seen a commitment to those principles in her work.

We should like to remind Ms. Mijatović that freedom of speech is not the same thing as outright permissiveness. Freedom of speech also entails a responsibility, which, alongside rights, forms the core of any democratic State. No one has the right to make unfounded and groundless accusations against any person, including officials. This universal principle applies both in our country and in other democratic States around the world, and is one of the signs of a mature democracy.

No one, not even the OSCE Representative on Freedom of the Media, is entitled to call into question the right of the independent judicial bodies of a particular State to be rigorous and impartial in their application of norms of domestic legislation which meet all international standards, including those of the OSCE.

Through its practical actions, Kyrgyzstan has always consistently demonstrated an unshakeable and indisputable commitment to the principles of democracy, including freedom of speech and human rights.

This is evidenced by the abolition of criminal prosecution for defamation at a time when in certain countries, defamation (dissemination of untrue information that damages a person's honour and reputation) is regarded not only as a civil but also as a criminal offence.

In conclusion, I should like to point out that Kyrgyzstan's support for the extension of the mandate of the OSCE Representative on Freedom of the Media is a vote for freedom of speech throughout the OSCE area.

Each session will have a moderator and a rapporteur. The consolidated summary will be forwarded to the Permanent Council.

Rules of procedure and working methods of the OSCE will be applied, *mutatis mutandis*, to the Conference.

The opening and closing sessions will be open to the media. The Conference will be held in Bangkok, Kingdom of Thailand. The working language will be English.

In connection with working session one, we note it is our understanding that the issues relating to countering violent extremism and combating terrorism will be discussed separately from the unrelated issue of cyber security.

DECISION No. 1204 RECOMMENDATION TO EXTEND THE MANDATE OF THE OSCE REPRESENTATIVE ON FREEDOM OF THE MEDIA

The Permanent Council,

Considering that, according to Ministerial Council Decision No. 1/13, the term of office of the current Representative of Freedom of the Media, Ms. Dunja Mijatović, expired on 10 March 2016,

1. Requests the Chairperson of the Permanent Council to transmit to the Chairperson-in-Office the draft decision of the Ministerial Council on the extension of the mandate of the OSCE Representative on Freedom of the Media (MC.DD/2/16/Rev.2);

2. Recommends to the Ministerial Council the adoption of this decision through a silence procedure with the period of silence expiring on 23 March 2016, at 12 noon CET.
